NH area as so many men are released into that community. Ron shared his vision with Bill for the ministry. We enjoy a fine relationship with Bill and he appreciates and encourages us in our work

#### **CAM IN KEENE, NH AREA**

Recently I met with Karl Bobbitt from Keene who shared his vision for aftercare ministry in Keene area. Our

board of directors would like to see the Lord expand aftercare ministries in other areas. Please pray for the Lord's direction in this new outreach to ex-offenders in the Western part of NH.

#### **IN-PRISON MINISTRIES**

It's such a blessing to hear about all the Bible studies and weekend seminars being held in NH prisons and jails. The volunteers are blessed and the men and woman who attend, see the love and concern they have for them; they hear about the Lord Jesus and how He can help them turn their lives around when they place their trust in Him; and they learn to walk more faithfully with the Lord.

#### FINANCIAL BLESSINGS

The Lord continues to bless CAM financially – for which we give Him praise. This enables us to help committed Christians with their rent until they can find employment. Jobs are difficult to find, but the Lord opens many doors and answered prayers for them. "THANK YOU" to you, our faithful supporters, for your generosity. We all are blessed.

We are privileged to be able to have four in-prison seminars each year at NH State Prison in Concord. Bob LaRoche and Rev. Brian Gower plan these; Bob organizing us volunteers and Brian works with Chaplain Jim to plan and invite instructors. Bob was involved with Prison Fellowship when he worked for Word of Life Bible Institute in Schroon Lake, NY. Many of the instructors have had involvement there as well.

Since last summer, volunteers and inmates have had lunch together in the chapel, and this has increased the time both for instruction and informal conversation. Volunteers sit at tables with 7 or 8 inmates. There is also opportunity for discussion at tables among the men based on auestions related to the previous content. Conversations often follow up on questions which remain.

Attendance at the Saturday night Prayer Fellowship worship service has increased. and attendees invite men in their units to attend seminars as well. This has resulted in increasing seminar attendance, especially when the speaker is remembered from a previous year.

At our last seminar there was a total of 98 men who attended, 83 of whom attended three or four sessions. Twenty-four men had not attended a previous seminar; many were new to the prison. On Friday night, twenty-one men had to be turned away due to lack of space (!), so we have talked about having future seminars in the gym.

Seminars have ongoing effects, some men have come into new faith; others are making commitments to grow in their faith and to serve the Lord more faithfully.

We are grateful for the freedom the State Prison allows for Christian programming, including these seminars. We will appreciate your prayers for the staff, volunteers and especially the men who are being served.

#### MY PERSONAL TESTIMONY BY KEN WEST

Not All Christians Shoot Their Wounded

"Brothers, if someone is caught in a sin, you who are spiritual should restore him gently. But watch yourself, or you may also be tempted. Carry each other's burdens, and in this way you will fulfill the law of Christ." Galatians 6:1.2

As a child I was sexually abused for ten years, from the ages of 4-14, by my uncle and his friends. Not only was I abused, but was forced to abuse others. I could tell no one about it for fear of my life – and the lives of others. At age 10, I found some one I could trust, or so I thought. When I confided in him, he also began abusing me. From then on I trusted no one.

I grew up confused about who I was, what I was, and my sexuality. I kept family and friends at a distance so the would not see the "real" me...... Then I began abusing others.

Because of the hatred I developed for myself, I decided to commit suicide. As I was deciding how to end my life, my TV was on. The channel was on Pat Robertson of the "700 Club." God's Word pierced my heart. In a flood of tears, I begged God to save me. Immediately I experienced relief, but did not truly understand what I had done.

After years of no true direction, I found a Bible-preaching church. Though I enjoyed the preaching and fellowship there, my insides were still in turmoil. I was living in sin and living a lie. I tried to take control of my own life by working more than 80 hours a week, and living in virtual isolation. Nothing changed. I believed the lies of the devil, and always returned to my sin and offences.

**BUT GOD** would not let me go. I needed to openly confess my sins to my victims, family, and to my church. It was the only way I could be free from the lie I was living. I had to be right with God.

I laid bare my soul before all the people I had hurt. I waited to be told what a terrible person I was. I waited for my pastor and Christian friends to confirm the lies the devil had been telling me. But instead, they told me they loved me and would help. My pastor said, "You're broken, but you can be fixed."

This was the first time I ever experienced unconditional love from others. It felt so good. O course, as part of being "fixed," the pastor needed to inform the deacons of the situation. When I came to church the following Sunday, I was once again was overwhelmed with the fear of rejection. What I received instead was words of love, encouragement and promises of prayer.



I turned myself in to the authorities. During the next 13 months while I was out on bail, I received intense Biblical counseling; was held accountable for all my actions, and received restoration of my soul.

I was handled firmly, lovingly, and patiently; much like Jesus does with us.

When I came to prison, I was at peace with my Lord, and I was FREE! I've been in prison now for more than 13 years, and have met many men who have been rejected, even by their local "Bible-preaching" churches, who should know better. This in turn has caused them to doubt God, and has impeded their healing. That is why I am so thankful for ministries like CAM.

I continually praise God for all that He has brought me through. He caused "...all things to work together for the good..." just as He promised.

The love I received from my Lord and home church, I'm able to pass on to the church behind the walls. Amen!
