On Wednesday, February 1, 2023, I had a nice visit from a former client, Mike Euliano. I met Mike about ten years ago from prison when he started attending our church, Merrimack Valley Baptist Church. While in prison, Mike was led to Jesus by his Christian cellmate, Josh. I met Mike at church, and we helped him transition back into society with financial help, prayer, and counseling. Today, Mike has his own successful tree service and attends Gate City Baptist Church in Nashua with fiancée, Jackie. Mike says he "prayed a lot"—what a nice visit.

In late January, while waiting to do my Bible study at Valley Street Jail, I had time to meet the new superintendent, Joe Constanzo, and tell him about CAM. It was a good visit as he was interested in what CAM does. For years, we have been bringing clothes in for inmates. Just recently we brought in three new ski jackets for the men.

Chaplain Bill Pelletier continues to set up prison visits at Concord prison for me. I visited nine men on December 21, 2022—for the most part, all Christians. The men we visit are close to being released, and we share how CAM can help them (read Jay Neeper's testimony on page 2).

The Concord reentry group meets every month and has a list of about twenty men either just out of prison or close to being released. It's a blessing how the reentry group works closely with each man. They help the men find a church and/or a job; provide rides, prayers, and clothes; and give some rent help if needed. They also provide encouragement—which we all need. And finally, but not least, they share the love of Jesus.

#### The Importance of the Church

With the holidays behind us and looking forward to spring. I would like to reflect on CAM's ministry in the post-pandemic era. It was good to finally get back in the jails and prison even with all the glitches starting up the Bible studies and office hours, etc. We thank God that it has happened.

Again, we would like to emphasize the importance of churches in our ministry. We, the volunteers, need the fellowship of church life, our small groups, and worship services. It recharges our batteries and keeps us focused on the Gospel and the Bible, for only they change the heart and lead to forgiveness.

A young man at a Bible study was having a difficult time: it was his first time in jail and he had no family or church contacts, only volunteers and fellow inmates. He was hoping to be out for Christmas. When that didn't happen, he became discouraged and missed a couple of Bible studies. He finally returned to the studies at the encouragement of other inmates, still discouraged but still seeking a relationship with the Lord.

Then his spirits began changing. A member of his church began to



visit him regularly, and his pastor also. They bought him a new study Bible, and how he treasured it. This renewed his interest in the Word of God, connecting the dots. He began to understand the richness of the Gospel.

#### MY PERSONAL TESTIMONY

In the past, I have had more than enough sin in my life. From lust, envy, drugs, and fights, I have struggled with them all. In 2007 I was arrested and accused of something that I did not have anything to do with. I remember being so scared, so frightened, and so cold. My knee's felt like rubber to the point they were weak and in pain. I remember the cop that took my fingerprints asked me which military branch did I serve in? I replied that I didn't serve. He said that I follow orders to good to not have been in the service.

The court-appointed counsel came to see me at the county jail. His advice was to plead out, and I told him no way. He proceeded to threaten me with twenty-five years to life in prison if I took it to trial. I was scared, very scared, but could not see admitting to something that I was innocent of.

I remember when my parents came for a visit at the county jail. They asked me what the appointed counsel had to say. I told them the lawyer wanted me to plead out to something I did not do. I told my father that I was innocent. What I did not know at the time was that day would be the last time my father would encourage me to make a major decision in my life. Shortly after that day, he passed away.

Sitting in my cell I was scared, really scared to the point of thinking about what kind of decision I needed to make for my life. Just then, God sent his messenger to whisper in my ear, saying, "You should go to the Bible study with me."

At that time, I was looking out the window. I turned around to face Eric Herring, and he told me they were playing a movie called *The Passion of the Christ* by Mel Gibson. I remember turning down the offer, and as I sat there thinking about the last few weeks, something came over me. I don't know what or how to describe it.

**John 10:16:** And I have other sheep that are not of this fold. I must bring them also, and they will listen to my voice. So there will be one flock, one shepherd.

My thoughts stopped, and I had this weird feeling that I should go to this movie.

When I sat down and watched that film of a man named Jesus and the horror of so much beating and tearing of flesh, like Simon of Cyrene I was compelled to hold back tears. I guess what Jesus was trying to tell me at that time was that he took that beating for me, and if I trust him, he would be walking with me on my journey and to not be afraid.

I could not remember feeling so spiritually empty and void after watching that movie. In the middle of a jailhouse cell, I fell to my knees facing out toward a little window that was in the cell and just asking him, as best as I knew, with watery eyes: O Lord Jesus, please come into my life and save me from my sinful life.

As another journey started for me. I was released from prison and walked down North Main Street in Concord, NH, and proceeded to the unemployment office looking for work and housing. I knew that I had to start my new life from the beginning, and there were no resources available to me at that time. I had no place to go and was now without a job and homeless. The only support that I had at that time was Christian Aftercare Ministries. Two volunteers from CAM—Steve and his wife, Donna—visited me daily on the street, and with their assistance and two individuals from the unemployment office, I was off and running in the right direction.

**John 17: 26:** I made known to them your name, and I will continue to make it known, that the love with which you have loved me may be in them, and I in them.

Hindsight is always 20/20, and I realized then that I should have tried to be better prepared to put important details in place prior to my release from prison. CAM directed me to local resources, provided clothing, snacks, and prayer with a relationship that helped me through that time. Housing is very limited in the Concord area, and I was sleeping in a car on the street, but through the grace of God I obtained housing at Whitfield House about a week later. I also started attending Bible study on Saturdays with MC/Men and was offered part-time work with one of the guys who attended the study. Another individual who attended the Bible study mentioned the possibility of full-time work at an automotive warehouse, so I applied, received the job, and am still employed there full time. I was also encouraged to attend CenterPoint Church for Sunday services and was welcomed to attend with members of CenterPoint. I am currently working on a vehicle to be able to be a little more independent, with the possibility of obtaining a career more in line with the gifts that the Lord has given me.

God clearly has placed many people in my life, and they continuously encourage me to continue my walk daily with Him. Thank you all for your support, and may God continue to bless you all!
