RE-ENTRY PROGRAM

Four years ago, CAM became the faith-based ministry for a federal re-entry grant applied for by the Commissioner of Corrections. The re-entry program has been started up again and I have been asked to be a member of the steering committee. The two directors, Ellis Therrien and Dick O'Leary, offer case management to some of the same people that CAM is helping. They will assist **Charlie**, one of our clients, with job leads, housing and case management. Through this program, I have made invaluable contacts

with many helping agencies in the Manchester area who assist our ministry to be more effective.

SATURDAY SERVICE AT CONCORD, NHSP

On Saturday night, Jan. 17, I had opportunity to speak at the chapel service to about 60 men regarding our ministry and how we are ready to help them when they are released from prison. I shared some biblical principles that will help them transition well. It is always a blessing to see how the Lord is working and blessing lives inside prison walls. My Personal Testimony By Wayne Andrews

I was raised in Maine the middle of three children. Church was: Dad dropped us off at church for Sunday School and picked us up after, so I knew about God. As a teen I was wild and rebellious until the woman that would become my wife lead me to the Lord. February 1979 I asked Christ into my heart and received Him as my Savior. I was baptized in a lake shortly after Ice-out early that Spring. I walked closely with the Lord for about 18 years. Then I got tired of doing good. (Galatians 6:9-10)

I fell into temptation. I was not the first. (I Corinthians 10:13) "No temptation has seized you except what is common to man ... " However, my eyes were closed to the way out with my back toward God. Eventually I committed my crime and was put in jail. When I first woke up in jail, I realized that all my earthly possessions were gone! (I did not even have my own underwear.) That is when I remembered Joshua 1:5. "No one will be able to stand up against you all the days of your life. As I was with Moses, so I will be with you: I will never leave you or forsake you." At that point I re-dedicated my life to God. I asked for a Bible and began to read and share the Word with all who would hear me. I was blessed enough to bring one person to the Lord in the county jail.

In Concord, NH State Prison I went to every biblical meeting I could find, up to 15 times a week in the chapel. I met Jean Metzger,

Later on I went to Berlin, NH. I still remember the empty room with bare walls that would be the chapel. As volunteers stopped in, I would support them all by attending and encouraging others to attend at least four or five times a week to discern what the Bible studies were all about. Eventually we had a consistent group attending. I personally became close to Dana Hoyt, a Baptist preacher who eventually became the Chaplain. When I was not in the chapel, I was in the yard where I walked the track, counseling and encouraging inmates one on one.

When I got out of Concord, the first year I spent reading the Bible each day all alone. Then I was invited to a men's fellowship where I met **Tim**. He became my chaperone when I was released.

So, now I go to church each Sunday, attend a life group on Wednesday nights when we meet at different houses each week – kind of like the old time churches did.

Through it all, Jean Metzger, along with Prison Fellowship and Christian After Care Ministries, has been there to help me send birthday cards, Christmas & Easter cards, asking what they could pray for on the list of needs I had. The main need I have is for their continued prayer support, but also for my dedicated commitment to the Lord. That's what we all need in those dark times when we feel that no one even cares. We can know that these wonderful people are out there praying for us.
