We at CAM are so thankful for Mike Grady's willingness to step into the acting director role when Paul Roussel went home to be with the Lord. His steady guidance and counsel helped us carry the ministry forward this past year. Please keep Mike and his wife, Ginny, in prayer during this difficult time.

MY PERSONAL TESTIMONY Part I

Ryan is a resident at Calumet House in Manchester. We got to know Ryan when he visited the CAM office and shared his testimony. We have prayed with him and given him counseling. Through your generous donations, Ryan has received clothes and shoes from the CAM clothes closet. Ryan's testimony, written while in prison, was first printed in Gobin, R. (2025). I was laying in my rack in closed custody wondering if I could expect the rest of my life to be like the last eleven years? Twenty-three years old and I had already spent one third of my life inside one institution or another. As a teenager, all I wanted was to get high, steal and cause mayhem. I would get high, burglarize cars and destroy property, among other harmful conduct.

My time in youth development centers exposed me to negative influences. It led me to believe violence and drugs imbued a courageous and manly lifestyle. As I got older, I fancied myself a tough guy and began robbing people at gunpoint for their drugs. I aspired to live on the fringes of society as a way of rebelling against the community at large.

I was arrested over and over again and never wanted to admit to myself or others there must be something wrong with my thinking. I figured the only thing wrong with what I did to get to prison was that I got caught.

The reason I continued to get arrested had everything to do with my beliefs and values. Throughout years in jails and prisons I turned to God to get me out of situations I put myself in. I remember hearing a pastor say God would answer my prayers, so I prayed to be let out early.

I wasn't praying for forgiveness or a new way of life. I was praying for the ability to outsmart law enforcement so I could stop going to prison for my criminal lifestyle.

I (thought) God would answer my prayers if they were for the greater good of humanity so I promised after I made millions as a criminal, I would find a way to give back. I thought I could manipulate God the way I tried to manipulate everyone else.

Looking back, it was really quite obvious I wasn't willing to live in the real world. I wasn't willing to accept and live by society's values even if it meant going to prison. The way I saw it, I never had anything to learn from any teachers, probation officers, or any type of authority figures. They were the ones who could learn by paying attention to the way I saw things.
